THE CORPORATION OF THE CITY OF SAULT STE. MARIE

BY-LAW NO. 4100

-

REGULATIONS: a by-law respecting noises in the City of Sault Ste. Marie.

THE COUNCIL of The Corporation of the City of Sault Ste. Marie, pursuant to paragraph 114 of subsection 1 of section 379 of the Municipal Act, R.S.O. 1960, charter 249 and amendments thereto ENACTS as follows:

1. Noises Prohibited

In the City of Sault Ste. Marie, no person shall:

- (1) ring any bell or cause or permit any bell to be rung;
- (2) blow or sound any horn or cause or permit any horn to be blown or sounded;
- (3) create, cause or permit any unusual noise; or
- (4) create, cause or permit any noise likely to disturb the inhabitants.

2. Exemptions

This by-law does not apply to the following:

- (1) The use in a reasonable manner of any apparatus or mechanism for the amplification of the human voice or of music in a public park or any other commodious space in connection with any public election meeting, public celebration or other reasonable gathering, provided the written approval of the Chief of Police has first been obtained.
- (2) Any military or other band or any parade, operating under written permission first obtained from the Chief of Police.
- (3) A newsboy, peddler, hawker or petty tradesman plying his calling legitimately and moderately.
- (4) A vehicle of the police or fire department, an ambulance or any public service or emergency vehicle while answering a call.
- (5) Any sound from any private radio, tape deck, transmitting apparatus or other similar device installed on or situated in or upon a motor vehicle for the sole benefit or entertainment of the operator and

occupants of such vehicle, provided same is not audible at a distance of twenty-five feet from such vehicle. (Amended by By-law 76-35)

- (6) Any case of public convenience or necessity.
- (7) The operation of any religious body including the Salvation Army as heretofore carried on.

3. OFFENCE

Any person who contravenes any of the provisions of this by-law is liable upon conviction therefore to a penalty not exceeding one thousand dollars exclusive of costs.

4. REPEAL

By-law 2666 of the former City of Sault Ste. Marie is hereby repealed.

5. EFFECTIVE DATE

This by-law takes effect on the day of its final passing.
